RESOLUTION NO 2002-R 041

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
CULVER CITY CALIFORNIA RECITING THE FACT OF THE
GENERAL MUNICIPAL ELECTION HELD ON APRIL 9 2002
DECLARING THE RESULT AND SUCH OTHER MATTERS
AS PROVIDED BY LAW

WHEREAS a General Municipal Election was held and conducted in the City
of Culver City, California on Tuesday April 9 2002, as required by the Charter of the City
of Culver City and

WHEREAS notice of the election was duly and regularly given in the time
form and manner as provided by law voting precincts were properly established that
election officers were appointed and that in all respects the election was held and
conducted and the votes were cast received and canvassed and the returns were made
and declared in the time, form and manner as required by the provisions of the Charter of
the City of Culver City and

WHEREAS pursuant to Resolution No 2001-R121 adopted on November
26 2001 the City Clerk canvassed the returns of the election and has certified the results
to this City Council the results are received, attached, and made a part hereof as "Exhibit
A"

NOW THEREFORE the City Council of the City of Culver City California
DOES HEREBY RESOLVE as follows

1 That the whole number of ballots cast in the City except absent voter
ballots was 3,974

1 That the whole number of absent voter ballots cast in the City was 1 961 and
2 the whole number of provisional ballots cast in the City was 59 making a total of 5 994
3 ballots cast in the City

4 2 That the names of persons voted for at the election for Member of the
5 City Council are as follows Albert Vera, Paul M Chip Netzel, David Hauptman Gary
6 Silbiger and Theodore (Ted) Smith III

7 That the name of the persons voted for at the election for City Clerk are as
8 follows Christopher Armenta and Lynn A Baril

9 3 That the number of votes given at each precinct and the number of
10 votes given in the City to each of the persons above named for the respective office to
11 which the persons were candidates were as listed in Exhibit "A"

12 4 That the City Council does declare and determine that Albert Vera was
13 elected as Member of the City Council for the full term of four years and Gary Silbiger was
14 elected as Member of the City Council for the full term of four years

15 5 That the City Council does declare and determine that Christopher
16 Armenta was elected as City Clerk for the full term of four years

17 6 That the City Clerk shall enter on the records of the City Council of the
18 City of Culver City a statement of the result of the election, showing (1) the whole number
19 of ballots cast in the City (2) the names of the persons voted for (3) for what office each
20 person was voted for and (4) the total number of votes given to each person

21 7 That the City Clerk shall immediately make and deliver to each of the
22 persons so elected a Certificate of Election signed by the City Clerk and authenticated the
23 City Clerk shall also administer to each person elected the Oath of Office prescribed in the
24 Constitution of the State of California and shall have them subscribe to it and file it in the

Office of the City Clerk Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected

11 That the City Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions
